Election of Life Members

The Chairman spoke of the enormous contributions made to the work of the Parliamentary and Scientific Committee by the past President, Lord Jenkin of Roding and by the former Chairman, Andrew Miller.

Dr Peter Jost proposed that **Lord Jenkin of Roding and Andrew Miller be elected as Life Members.** This was seconded by Dr Stephen Benn and approved by the meeting.

To Receive the Annual Report for 2014

The Annual Report for 2014 had been circulated to members with papers for the meeting.

The report included a Foreword by the President and a report on the programme by the Chairman, membership lists, minutes of the 2013 AGM, and a list of meetings held in 2014.

During the year meetings were held on Badgers, Natural Capital, Marine Science, Hydraulic Fracturing, Realising our Potential, A Levels, Infrastructure, Ebola Virus, Energy Storage and Dementia. To celebrate the Committee's 75th Anniversary HRH The Duke of Edinburgh held a Reception at Buckingham Palace on 11th November and later that month our guest of honour at the annual lunch was the Prime Minister. The annual SET for BRITAIN poster exhibition and competition for early-stage researchers was held in Parliament during science week.

The meeting agreed to receive the 2014 Annual Report.

To Receive the Financial Statement for 2014 Estimates for Income and Expenditure for 2015

Lord Willis of Knaresborough presented the Financial Statement for 2014 which had been circulated to Members with the Estimates for Income and Expenditure. There was a surplus for the year of £8,584.

Lord Willis said he was pleased to report the most financially successful 36 months in the Committee's history.

A combination of energetic recruitment, and careful internal management has resulted in a combined surplus for 2013 and 2014 of nearly £20,000. It is likely that 2015 will also produce a comfortable surplus.

Lord Willis advised that the Parliamentary and Scientific Committee had also been very generously supported by an anonymous benefactor. This has enabled us to improve our Website, and also to hold a magnificent reception at Buckingham Palace to celebrate our 75th anniversary.

During the past two years there has been considerable discussion about the future role(s) of the P&SC. The improved financial position means that we can now start to move these initiatives forward.



The Council had approved the Estimates for Income and Expenditure for 2015 and a surplus of £3,000 is anticipated for 2015.

David Youdan proposed that the 2014 Financial Statement and 2015 Estimates be accepted, this was seconded Dr John Dudeney and approved by the meeting.

SET for Britain

SET for Britain, the annual poster competition and exhibition for early-stage researchers was held in the Attlee Suite, Portcullis House on Monday 9th March 2015.

During the day over 70 Parliamentarians from both Houses of Parliament visited the Attlee Suite to view the posters (210 in all) and to meet their local early-career researchers. The competition was divided into three separate sessions: Biological and Biomedical Sciences; Physical Sciences (Chemistry and Physics); and Engineering and Mathematical Sciences. Judging panels for each category were formed of distinguished scientists and engineers from the Society of Biology, The Physiological Society, the Royal Society of Chemistry, the Royal Academy of Engineering, the Council for the Mathematical Sciences and the Institute of Physics.

Alan Malcolm reported that in March, our long serving (nearly 25 years) Administrative Assistant, Annabel Lloyd indicated that she wished to retire from full time work.
